Use your judgment. Injured employees should be sent to the nearest medical facility capable of providing medical care as quickly as possible, given the severity of the injury. Sending non-emergency situations to a hospital emergency department will delay the employee's access to medical treatment.

Life Threatening Injuries: Are (but not limited to) injuries that result in loss of consciousness, a deep laceration, a head injury, a fall from a ladder or down a staircase, possible loss of a limb or life. **Call 911** or go to the nearest hospital emergency department for treatment.
